All APHA, AQHA, TB and ApHC registered horses who are sired by a stallion that sold in the 2017 Color Classic Stallion Service Sale are eligible to compete in the 2017 Color Classic Futurity





2017 Color Classic Stallion Service Sale Rules

1. The Virginia Paint Horse Club (VPHC) Color Classic Stallion Service Sale (CCSSS) is open to APHA, AQHA and Thoroughbred (Jockey Club) registered stallions standing for the 2017 breeding season.
2. For an APHA, AQHA, TB and ApHC registered horse to be eligible to compete in the VPHC Color Classic Futurity the horse's sire must be nominated to the VPHC CCSSS and sell in the CCSSS during the current competition year.
3. Stallions' breedings are sold on a first come first serve basis at half of the advertised stud fee plus a \$20 office fee per service sold.
4. A stallion's breeding must SELL in the CCSSS during the current competition year in order for his offspring to be eligible to compete in VPHC Color Classic Futurity Classes.
5. All stud fees, including Private Treaty, must meet the minimum stud fee of \$300 in order to participate in the VPHC CCSSS program.
6. Stallion nomination forms must be completed by stallion owner or stallion agent and submitted to the VPHC CCSSS Chair. Stallion nominations will be accepted beginning on October 1, 2016 through May 1, 2017.
7. Breedings are sold on a first come first serve basis. Any breeding not paid in full within 7 business days of purchase will be resold. The 2017 sale will open on November 15, 2016 and run through June 1, 2017. Any purchases after June 1, 2017 require stallion owner approval.
8. Make checks payable to the VPHC CCSSS. Payment is also accepted via PayPal with a 4% convenience fee.
9. There are NO refunds for CCSSS purchased breedings and VPHC CCSSS breedings may NOT be resold.
10. Mare owners must comply with the stallion's breeding contract. Booking fees, chute/collection fees and shipping fees are NOT included in the CCSSS purchase price and are payable to stallion owner or stallion agent as identified in breeding contract. All matters that arise following the purchase of the breeding through the CCSSS will be handled by the stallion and mare owner directly without any involvement by the VPHC.
11. The resulting foal of the CCSSS breeding will receive ONE FREE ENTRY into the Color Classic Futurity. This FREE ENTRY may be used through the resulting foal's 3 year old year. This free entry allows the resulting foal to compete in one Color Classic Futurity class REGARDLESS of whether the foal's sire sold in the CCSSS during the current competition year. To compete in additional Color Classic Futurity classes the foal must meet the CCSSS rule requirements. This free entry is NOT transferrable and may only be used on the resulting offspring from the VPHC CCSSS breeding. The FREE ENTRY certificate must be presented at the time of entry.
12. Owners of CCSSS nominated stallions will receive a free VPHC individual membership (upon request). If the stallion's breeding sells, the stallion owner will receive ONE FREE ENTRY into the Color Classic Futurity to be used through the resulting foal crop's yearling year (the competition year in which the breeding was SOLD and the two additional competition years). This free entry may be used on ANY horse that is sired by a stallion that SOLD in the VPHC CCSSS during the current competition year. The FREE ENTRY certificate must be presented at the time of entry.

13. If the stallion DOESN'T SELL by July 1st, the stallion owner may pay a "Buy Back/Repurchase Fee" as described on the stallion nomination form. The stallion owner will then receive ONE FREE ENTRY to be used during the current competition year that the breeding was REPURCHASED. These free entries may be used on ANY horse that is sired by the repurchased stallion. The FREE ENTRY certificate must be presented at the time of entry.
14. Buy back/repurchase of a donated service by anyone other than the stallion owner will receive ONE FREE ENTRY to be used during the current competition year that the breeding was REPURCHASED. Stallion owner approval of repurchase is required. This free entry may be used on ANY horse that is sired by the repurchased stallion. The FREE ENTRY certificate must be presented at the time of entry.
15. All Funds generated from the VPHC CCCSS (100%) (excluding the admin fee) will be paid out in the 2017 Color Classic Futurity Classes held at the VPHC Color Classic Futurity Show.
16. VPHC is not responsible for the accuracy of any information provided on nominated stallions, including, but not limited to pedigree, genetic testing results, show records, progeny, or other program eligibility. Please contact the stallion owner directly prior to purchasing a breeding.
17. VPHC reserves the right to alter the conditions of the CCCSS as necessary.

2017 Color Classic Futurity Rules



VPHC reserves the right to refuse entries from anyone not a member in good standing with the APHA.

Owner & Exhibitors of horses entered in the VPHC Color Classic Futurity MUST be current members of VPHC.

ELIGIBILITY REQUIREMENTS:

1. Any APHA, AQHA, TB or ApHC horse sired by a stallion who sold in the 2017 Color Classic Stallion Service Sale (CCSSS) is eligible to compete in the 2017 Color Classic Stallion Service Sale.
2. [A1]The Color Classic Futurity will be held in conjunction with the VPHC Color Classic Futurity Show and will be judged by the same judges.
3. **Refunds:** If a class is canceled due to lack of entries, a full refund will be made to the owner if requested. The refund will be taken off of the owner or exhibitor's show bill, which is due at the end of the show. VPHC will hold futurity classes with only one horse if the owner requests the class be held.
4. **Substitutions:**
 - a. Will be allowed ONLY with a valid vet certificate
 - b. Substitute horse must be owned by the same owner as the horse it is replacing.
5. **Paid entries may be transferred to new owner if horse is sold**
 - a. A request form original owner must be made to the Futurity Chairman and new document of ownership of horse is required.
 - b. Transfer of VPHC membership is NOT allowed. New owner must purchase their own membership.
6. The Color Classic Futurity classes may be added to or modified at anytime with approval of Officers, Board and Futurity Committee.
7. Weanling classes may be split into early/late if entries warrant (13 entries or more, split date will be the average dates of birth.)
8. A tie-breaker judge will be selected prior to the start of the show.
9. Color Classic Futurity classes will pay back 80% of entry fees, in addition: VPHC guarantees an added money purse in each class. Total purse amount will be determined based on the money in the Color Classic Stallion Service Sale that year and any sponsor added money. 100% of sponsorship money will be paid out.
10. Any futurity entry-testing positive for Drugs and/or Tail Fixing under APHA rules will forfeit any futurity money and/or awards won. Futurity winnings will be mailed out within 6 weeks of the show unless waiting on APHA test results.
11. Checks returned by the bank for non-payment will be assessed an additional charge of \$50.00 per occurrence.
12. The Futurity Chairman in attendance at the show will settle any dispute concerning the rules of the futurity.
13. **The following documents must accompany each entry:**
 - a. Entry form with payment for futurity classes
 - b. APHA registration certificate or breeding certificate
 - c. Negative Coggins
 - d. Membership form (if applicable)
14. All futurity entries must submit a Color Classic Futurity Show Entry Form to the Show Secretary.
15. Please make all checks payable to: VPHC
16. The 2017 Color Classic Futurity payback amounts will change and amounts will be decided by the number of horses entered into each class. The total purse will be divided by the number of Color Classic Futurity entries and each horse will carry a set fee into that class (this will be called a factor). **EXAMPLE:** Total purse for all classes is \$4000 and there are 50 horses entered. each horse will carry to it's class \$80. The purse for each class will be the factor for each horse (in this case \$80) and the factor will be multiplied by the number of entries in that class. A class with 12 entries would have a purse of \$960; a class of 1 entry will have a purse of \$80.
