

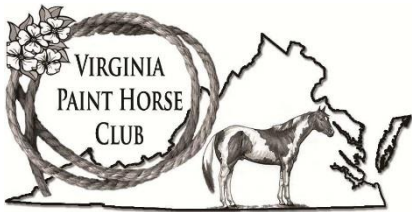

## 2017 Virginia Paint Horse Club Virginia Bred Futurity Rules



VPHC's Virginia Bred Program is sponsored in part by a grant from the Virginia Horse Industry Board (VHIB).

*VPHC reserves the right to refuse entries from anyone not a member in good standing with the APHA.*

**Owners & Exhibitors of horses entered in the VPHC Virginia Bred Futurity MUST be current members of VPHC.**

### ELIGIBILITY REQUIREMENTS:

1. Classes will be open to APHA Regular Registry and Solid Paint Bred horses foaled in Virginia.
2. Weanling classes may be split into early / late if entries warrant (13 entries or more, split date will be determined by the averaged dates of birth).
3. These classes may be added to or modified at any time with the approval of VPHC Officers, Board and Futurity Committee.
4. The VBP Futurity will be held in conjunction with the VPHC's Fall Color Classic and judged by the same judges.
5. If a tie results, a predetermined tiebreaker judge will be used for awards only; money will be split evenly.
6. VBP Classes will pay back 80% of class entry fees. In addition, VPHC guarantees added money incentives in each class. Total purse amount will be determined based on VHIB grant funds and any sponsor added money. 100% of sponsorship money will be paid out.
7. Any futurity entry that tests positive for APHA identified illegal drugs or other rule infraction will forfeit all money and awards.
8. Futurity winnings will be mailed out within 6 weeks of the show unless awaiting APHA drug test results.
9. All entries must be complete a show entry form and pay show office fees regardless of entering an APHA class or not.
10. **Refunds:** If a class is canceled due to lack of entries, a full refund will be made to the owner if requested. The refund will be taken off the owner's show bill due at the end of the show. VPHC will hold futurity classes with only one horse if the owner requests the class be held.
11. **Substitutions:**
  - a. Will be allowed ONLY with a valid signed vet certificate.
  - b. Substitute horse must be owned by the same owner as the horse it is replacing.
12. **Paid entries may be transferred to new owner if horse is sold.**
  - a. A request from original owner must be made to Futurity Chairman and new documentation of ownership of horse is required.
  - b. Transfer of VPHC membership is NOT allowed. New owner must purchase their own membership.
13. The Futurity Chairman in attendance at the show will settle any dispute concerning rules of the futurity.
14. **The following documents must accompany each entry**
  - a. Entry form with payment for futurity classes,
  - b. APHA Registration certificate or breeding certificate
  - c. Negative Coggins
  - d. Membership form (if applicable)
15. Checks returned by the bank for non-payment will be assessed an additional charge of \$50.00 per occurrence.
16. Please make all checks out to: VPHC
17. 2017 Virginia Bred Futurity pay back amounts will change and amounts will be decided by the number of horses entered into each class. The total purse will be divided by the number of Virginia Bred entries and each horse entered will carry a set fee into that class (this will be called a factor).  
**EXAMPLE:** Total purse for all classes is \$4000 and there are 50 horses entered, each horse will carry to its class \$80. The purse for each class will be the factor for each horse (in this case \$80) and the factor will be multiplied by the number of entries in that class. A class with 12 entries would have a purse of \$960; a class of 1 entry will have a purse of \$80.
