



## 2022 VPHC Color Classic Stallion Service Sale Rules

1. The Virginia Paint Horse Club (VPHC) Color Classic Stallion Service Sale (CCSSS) is open to APHA, AQHA, ApHC and Thoroughbred (Jockey Club) registered stallions standing for the 2022 breeding season. EXCEPTION: deceased or nonbreeding stallions (without frozen semen available) that were nominated within the last 3 years (2018-2021), may be nominated and purchased.
2. For an APHA, AQHA, ApHC or Jockey Club registered horse to be eligible to compete in the 2022 VPHC Color Classic Futurity, the horse's sire must be nominated and purchased in the 2022 VPHC CCSSS.
3. Stallions' breedings are sold on a first come first served basis at half of the advertised breeding fee plus a \$20 admin fee per service sold. Any breeding not paid in full within seven (7) business days of purchase will be relisted. The 2022 sale will open by November 15, 2021 and run through June 1, 2022. All purchases after June 1, 2022 require stallion owner approval. All stallion purchases must be completed by August 1, 2022.
4. All stud fees, including Private Treaty, must meet the minimum stud fee of \$300 in order to participate in the CCSSS program.
5. Stallion nomination forms must be completed by stallion owner or stallion agent and submitted to the VPHC CCSSS Chair.
6. Make checks payable to VPHC CCSSS. Any returned check will incur a \$50.00 insufficient funds fee. Payment is also accepted via PayPal with a 4%convenience fee.
7. There are NO refunds for VPHC CCSSS purchased breedings and VPHC CCSSS breedings may NOT be resold.
8. Mare owners must comply with the stallion's breeding contract. Booking fees, chute/collection fees and shipping fees are NOT included in the CCSSS purchase price and are payable to stallion owner or stallion agent as identified in breeding contract. All matters that arise following the purchase of the breeding through the CCSSS will be handled by the stallion and mare owner directly without any involvement by the VPHC.

9. Owners of CCSSS nominated stallions will receive a free VPHC individual membership (please complete the online membership form at: [www.virginainpainthorseclub.org/membership.html](http://www.virginainpainthorseclub.org/membership.html)). If the stallion's breeding sells, the stallion owner will receive ONE FREE ENTRY into the 2022 VPHC Color Classic Futurity. This free entry may be transferred and used on ANY horse that is sired by the nominated stallion.

10. Stallion owner purchase period: if the stallion DOESN'T SELL by June 1, the stallion owner may purchase the breeding at half of the advertised breeding fee plus a \$20 admin fee in order to make ANY horse that is sired by the purchased stallion eligible to compete in the 2022 VPHC Color Classic Futurity. The stallion owner will then receive ONE FREE ENTRY into the 2022 VPHC Color Classic Futurity. The free entry may be transferred and used on ANY horse that is sired by the purchased stallion. All stallion owner purchases must be completed by August 1, 2022.

11. Exhibitor purchase period: if the stallion DOESN'T SELL by June 1, an exhibitor may purchase the breeding at \$300 plus a \$20 admin fee in order to make ANY horse that is sired by the purchased stallion eligible to compete in the 2022 VPHC Color Classic Futurity. All exhibitor purchases require stallion owner approval and must be completed by August 1, 2022.

12. All funds generated from the VPHC CCSSS (100%) (excluding the admin fee) will be paid out in the 2022 Color Classic Futurity classes held at the VPHC Virginia Color Classic Futurity Show.

13. Futurity exhibitors must be in good standing with their respective national association (APHA, AQHA, ApHC) to receive a futurity check.

14. All stallion purchases must be completed by August 1, 2022. A complete list of eligible sires will be posted prior to the first VPHC Color Classic Futurity entry deadline.

15. Stallion owners will receive 10% of the VPHC Color Classic Futurity purse earned by their progeny. For example, when a stallion's foal earns \$200 for their share of the class purse, the foal owner will receive \$180 and the stallion owner will receive \$20. The amounts will be calculated per class.

16. VPHC is not responsible for the accuracy of any information provided on nominated stallions, including, but not limited to pedigree, genetic testing results, show records, progeny, or other program eligibility. Please contact the stallion owner directly prior to purchasing a breeding.

17. VPHC reserves the right to alter the conditions of the CCCSS as necessary.

18. If you plan to compete in the 2022 VPHC Color Classic Futurity, please consult the VPHC Color Classic Futurity rules for additional conditions.
